### Liability Waiver

#### LIABILITY WAIVER AND RELEASE AGREEMENT

For international clients, it is understood that the Services are being provided from Illinois, USA, and any disputes shall be resolved under U.S. jurisdiction.

## 7. Entire Agreement

This document constitutes the entire agreement between the Client and Practitioner. If any provision of this Agreement is found to be unenforceable or invalid, the remainder of the Agreement shall remain in full force and effect.
